RE: Universal Pre-K Program Review– Implementation of WVBE Policy 2525

Effective August 13, 2012, revised WVBE Policy 2525 requires a WV Universal Pre-K Program Review a minimum of once every three years in each county by the WVDE Office of Early Learning, in collaboration with the WVDHHR and Head Start State Collaboration Office. The program review will be conducted through a one and one half day county visit. The program review will consist of a desktop audit, site visits and a county collaborative team interview. The purpose of the program review is to ensure counties continue to implement WV Universal Pre-K programs in alignment to policy and assist with continuous quality improvement with the comprehensive collaborative model. As part of this review process, your county has been identified for a Universal Pre-K Program Review for the 2014-15 school year. The program review schedule for the upcoming school year is attached.

The WV Universal Pre-K Program Review assists the WV Pre-K Steering Team in providing individualized technical assistance to county collaborative early childhood teams. There are several resources available to assist each team in understanding and preparing for the WV Universal Pre-K Program Review.
